#### SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. For your information, the minimum 20% reservation for each LEA may be found HERE.

Through discussions in open meetings, surveys, and district meetings Beaver River discussed ideas and potential oppotunities for use of the American Rescue Plan funds. Stakeholders involved were parents, students, faculty and staff, and commnity members. Meetings were held in person and virtually. Surveys were sent out to all stakeholder groups. Faculty and staff held department and grade level meetings, with the ultimate outcome of making proposals that not only indicated what was requested, but data to support the request and the opportunities for sustainability after the funds are expensed.

As we work through the plan, we are colleciting baseline and activity data. This data will be shared at board meetings, webinars, and our strategic planning committee which consits of multiple stakeholders including parents, students, faculty and staff, and committy members.

The district will provide both additional classroom teachers, enrichment, and AIS support teachers to reduce class sizes for social distancing purposes and target the specific needs of students that need academic support.

In order to provide distancing in classroom the school district will purchase furniture that is flexible for both group and individual activities.

Both of these activites provide increased spacing that limits the need for quarantining students. We have learned during the school year that spacing is key and preventing quarantine of students is what keeps them in school. Transmission of the virus has not been seen in school but rather postive cases can be traced to outside contacts.

The district will provide both additional classroom teachers, enrichment, and AIS support teachers to reduce class sizes for social distancing purposes and target the specific needs of students that need academic support. The support provided is based on indivdual assessment of student deficiencies, either through internal assessments or state assessments. Small group, Tier 2 interventions that target those difficiences will be scheduled into students daily and weekly activities.

In addition these programs will provide classroom and student level data to the providers of our after school and summer activities, thus aligning all activities to meet the deficiencies of learning loss and academic need.

The district will hire a home school coordinator for a 10-month position for three years to coordinate services between school, families and county services.

In order to provide distancing in classroom the school district will purchase furniture that is flexible for both group and individual activities. We use our internal assessments for both academic and social and emotional needs. This data is tracked on an individual basis. We are also workign iwth our regional informaoni center on developing a data dashboard that provide on-time reporting of data to district users.

The distict will hire staff (Teachers, Aides, and Teaching Assistants) to provide support either directly or indirectly by providing academic intervention services, and reducing class size..

Additional support staff to provide academic support through monitoring, in class time instruction and assessment.

Air Conditioning will be provided for the central server room. This will help maintain and prolong the life of the technology equipment used for academic and management needs.

In order to provide distancing in classroom the school district will purchase furniture that is flexible for both group and individual activities.

The school district will contract with BOCES to develop a data dashboard that enhances data accessibility for teachers, administrators and board members, allowing for decisions that are data driven in a timely manner. The data dashboard developed with include academic, social emotional mental health and demographic data including those students disproportionately impacted by the COVID-19 pandemic, including students from low-income families, students of color, English learners, children with disabilities, students experiencing homelessness, children in foster care, and migratory students. Essentially each student will have a "picture" that can be painted based upon the data collection that providers can use to target the needs for those students.
